<b>What is the overall <a href="#">deductible</a>?</b>	For <a href="#">out-of-network providers</a> : \$500/ individual or \$1,500/ family	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. Other than office visits and <a href="#">durable medical equipment</a> , all other services described in this document are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost sharing</a> and before you meet your <a href="#">deductible</a> . <b>Are there other <a href="#">deductibles</a> for specific services?</b>	Yes. \$50 for <a href="#">out-of-network providers</a> <a href="#">home health care</a> services. <b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b>	Medical: \$1,500/individual or \$4,500/family <a href="#">Prescription drugs</a> : \$2,000/individual or \$6,000/family	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. #### Does this plan provide Minimum Essential Coverage? Yes.
